Bulk Waste - Vouchers and Upcoming Curbside Collection

Kerrville, Texas (August 21, 2015) – The City of Kerrville Solid Waste Division would like to remind residents of the voucher system available for bulk waste disposal. In addition, information on the upcoming schedule for curbside collections for bulk waste is provided. These opportunities to discard unwanted bulk waste items are part of the integrated solid waste services provided for all residential units within the City of Kerrville.

Residents are able to discard unwanted items four times per year with two voucher opportunities and two curbside collections. These quarters alternate with a voucher opportunity as the first quarter during the months of **July, August, and September**. Vouchers are valid during these months and must be used by the end of September.

The second quarter, which consists of **October, November, and December**, will be a curbside collection quarter. The collection will occur during the month of **October**.

The third quarter months of **January, February, and March** returns the voucher opportunity. Vouchers are valid during these months and must be used by the end of March.

The fourth quarter, which consists of **April, May, and June**, will be a curbside collection quarter. The collection will occur during the month of **April**. This quarterly schedule repeats itself every July.

Bulk waste items include residential appliances such as washers, dryers, stoves, water heaters, furniture, and other items not regularly picked up during weekly collections. Refrigerators, freezers, and A/C units are allowed only if the refrigerant has been reclaimed, and the unit has been tagged by a licensed technician.

Current Bulk Waste Quarter Highlights (July, August, September – drop off with voucher):

- Vouchers are available at City Hall, 701 Main Street for the account holder to pick up;
- Vouchers expire September 30, 2015;
- One voucher per residential unit is valid for one trip to the Transfer Station;
- Transfer Station Hours: Monday – Friday 7:30 a.m. to 4:50 p.m.; Saturday 8:00 a.m. to 1:00 p.m.;
- A copy of the most recent utility bill must be presented with the voucher at drop off;
- All exposed items such as in a pickup truck or trailer must be covered or secured during transportation; and

- Brush can only be disposed of during the drop off quarters at the Transfer Station and during the monthly curbside brush collections. Brush will not be collected during curbside collection for bulk waste.

Schedule for Bulk Curbside Collections:

The following schedule is based on your collection day for regular garbage.

Monday Collection: October 5 – 9

Tuesday Collection: October 12 – 16

Wednesday / Thursday Collection: October 19 – 23
