The Popular Annual Financial Report (PAFR) is designed to provide an easy to read, high-level summary of the City's financial activities and other information. This is the third PAFR published by the City of Kerrville and represents financials for fiscal year 2024. The PAFR does not contain detailed information about all City funds. Information is presented at a Citywide level to provide readers an overall financial picture. Financials relating to the City's component unit funds are not included in the PAFR.

The ACFR was prepared in conformance with generally accepted accounting principles (GAAP) and the City's financial information was independently audited by Forvis Mazars, LLP. The City of Kerrville received an unmodified opinion, which means the City's financials were free of any material accounting errors requiring adjustment by the auditors.

About the City of Kerrville

HISTORY

In 1856, Joshua Brown donated four acres of land located on the Guadalupe River to Kerr County. The tract of land became known as "Kerrsville" and was established as the county seat of Kerr County. Eventually the "s" in "Kerrsville" was dropped and the settlement became known as "Kerrville". Early settlers were primarily merchants and ranchers of German origin. The opening of the cattle trails to Kansas in the 1870's contributed to the early growth of Kerrville, drawing new settlers to the area and fostering business expansion. As a result of this growth, the citizens voted to establish Kerrville as an incorporated city in 1889. After incorporation, Captain Joseph A. Tivy was elected as the first mayor of Kerrville. City administrators oversaw development and were responsible for the establishment of public schools. To honor the Captain's crucial role in this process, Kerrville's first high school was named "Tivy High School" and is still in existence today.

CLIMATE

At an elevation of 1,645 feet above sea level, Kerrville has a semi-arid climate, averaging approximately 28 inches of rain per year. August is the warmest month with an average high temperature in the mid-nineties. January is the coldest month with average lows in the mid-thirties.

LOCATION

Kerrville is ideally located in the heart of the Texas Hill Country, 65 miles northwest of San Antonio and 103 miles southwest of Austin. Other major metropolitan areas, Dallas and Houston, are both less than 300 miles from Kerrville. Kerrville is easily accessible from Interstate Highway 10 or State Highways 16, 27, and 173.

TOPOGRAPHY

The Guadalupe River runs through Kerrville, providing the City not only with drinking water, but with ample recreational opportunities, beautiful views and tourist appeal. Kerrville boasts a 6 mile long river trail and a beautiful downtown riverfront park, Louise Hays Park. Louise Hays Park offers a splash pad, amphitheater, dog park, covered pavilions, playgrounds, and is home to many free community events. In addition, Kerrville-Schreiner Park offers visitors 517 acres of trails, camping, fishing, swimming and recreation on the Guadalupe River.

The balance sheet is broken down into assets, liabilities, and equity. The purpose of the balance sheet is to give insight about resources available and serves as a summary of what the City "owns" and what the City "owes".

The balance sheet reports a separate section for deferred inflows of resources. This separate element represents an acquisition of net assets that applies to a future period(s) and will not be recognized as an inflow of resources (revenue) until that time. For example, grant funding is recorded as "unearned revenue" until expenses are incurred, at which time funds are recorded as revenue.

The City of Kerrville maintains 12 individual governmental funds. Four of these are considered major funds. A major fund contributes heavier to the overall financials than non-major funds. Major funds are determined annually based on a multitude of factors. The City's major funds in fiscal year 2024 include the General Fund, Governmental IP Fund (Capital Projects), Grant Fund, and General Debt Service Fund.

Statement of Activities (Citywide)

The City's Statement of Activities compares revenues and expenses for the entire City for both fiscal years 2024 and 2023. For comparison purposes the Statement of Activities in the private sector is known as a profit and loss statement. The full Statement of Activities can be found on page 35 and 36 of the City's FY2024 ACFR.

The City's net position increased from \$166,226,836 to \$172,609,190 during fiscal year 2024. This growth is primarily driven by higher charges for services, including an increase in EMS revenue. Additionally, investment earnings performed well due to higher interest rates, and property tax revenue increased as a result of overall valuation growth, however this was partially offset by a decrease in the tax levy.

Statement of Net Position (Citywide)

The City's Statement of Net Position provides a comprehensive overview of its financial health as of September 30, 2024. This statement outlines the City's assets, liabilities, and overall net position, offering stakeholders insight into the city's liquidity and ability to meet financial obligations both now and in the future.

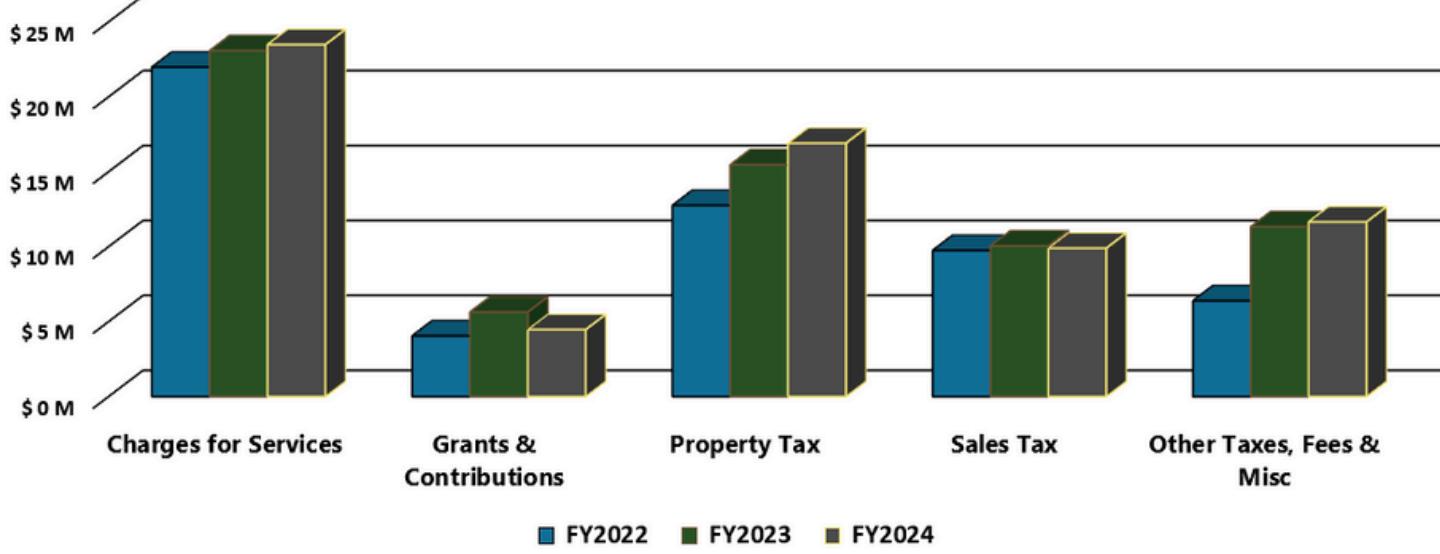

CITYWIDE REVENUE SOURCES



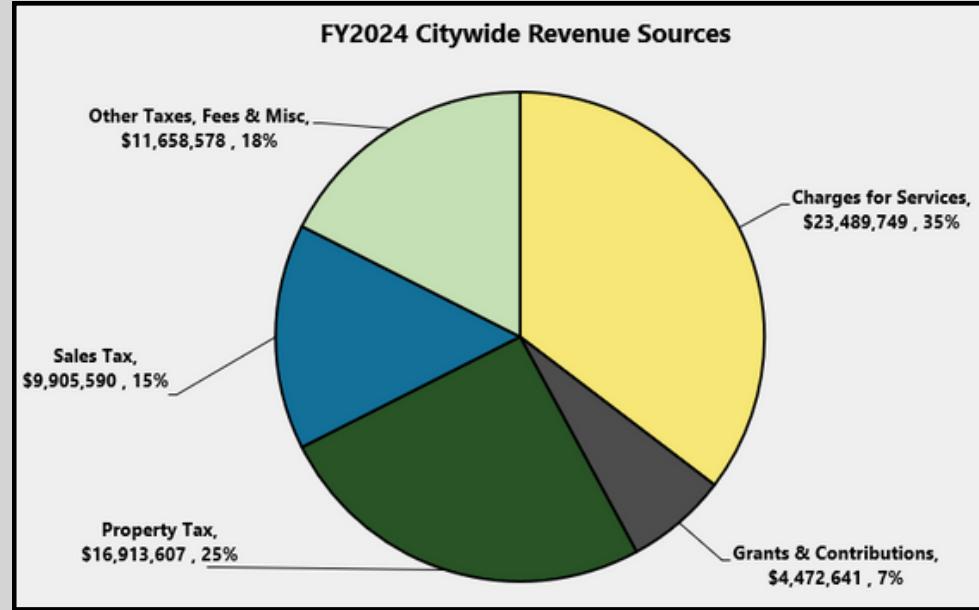

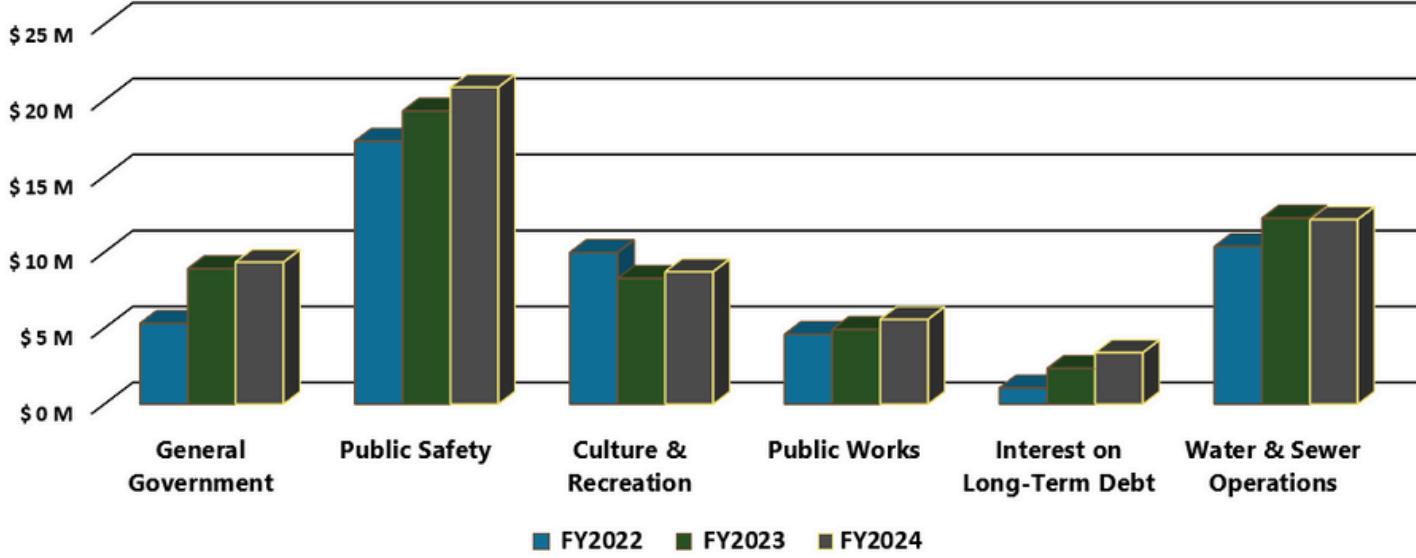

CITYWIDE EXPENSES BY FUNCTION

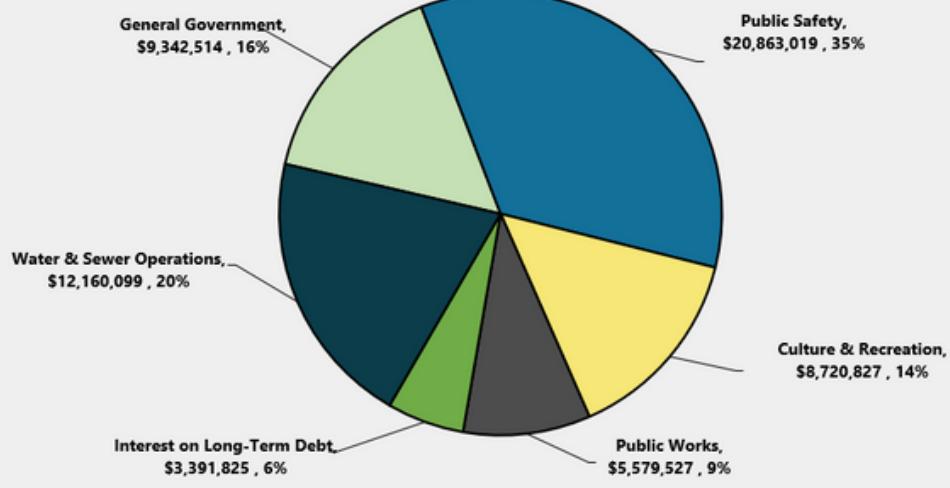

The City's total expenses for the provisions of services and programs was \$60,057,811 in fiscal year 2024, compared to \$56,035,351 in fiscal year 2023. The increase is primarily due to expenses to public safety and interest on long-term debt.

FY2024 Citywide Expenses by Function

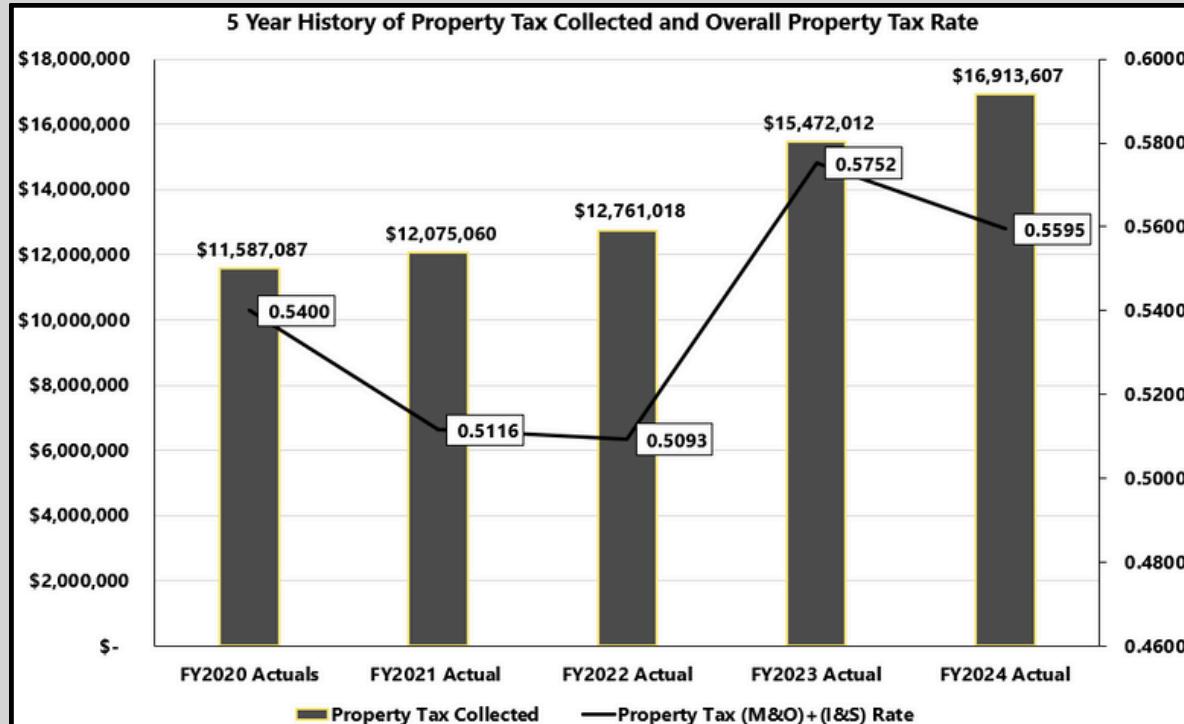

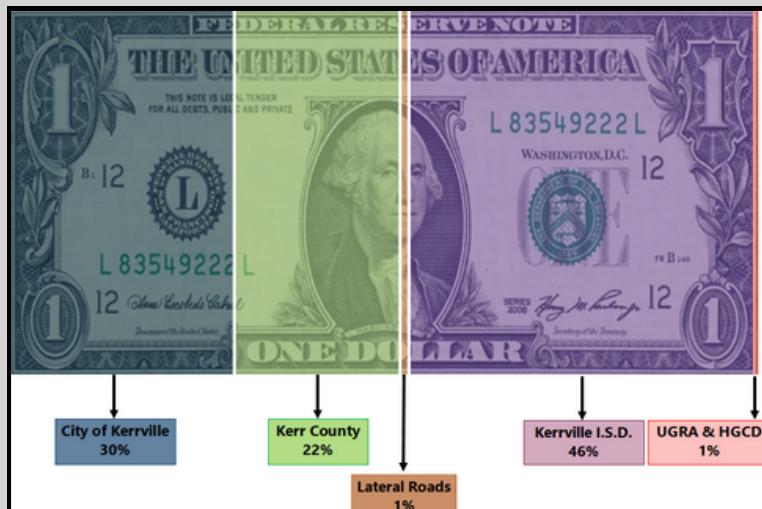
Property Tax

The City's property tax rate consists of two components: the Maintenance and Operations (M&O) rate and the debt service, or Interest and Sinking (I&S) rate.

- The M&O rate represents the portion of property taxes used to fund the operations and maintenance of the City, including general fund personnel costs, supplies, professional services, and other general operating costs.
- The I&S rate represents the portion of property taxes allocated to repaying the City's outstanding long-term general fund debt obligations.

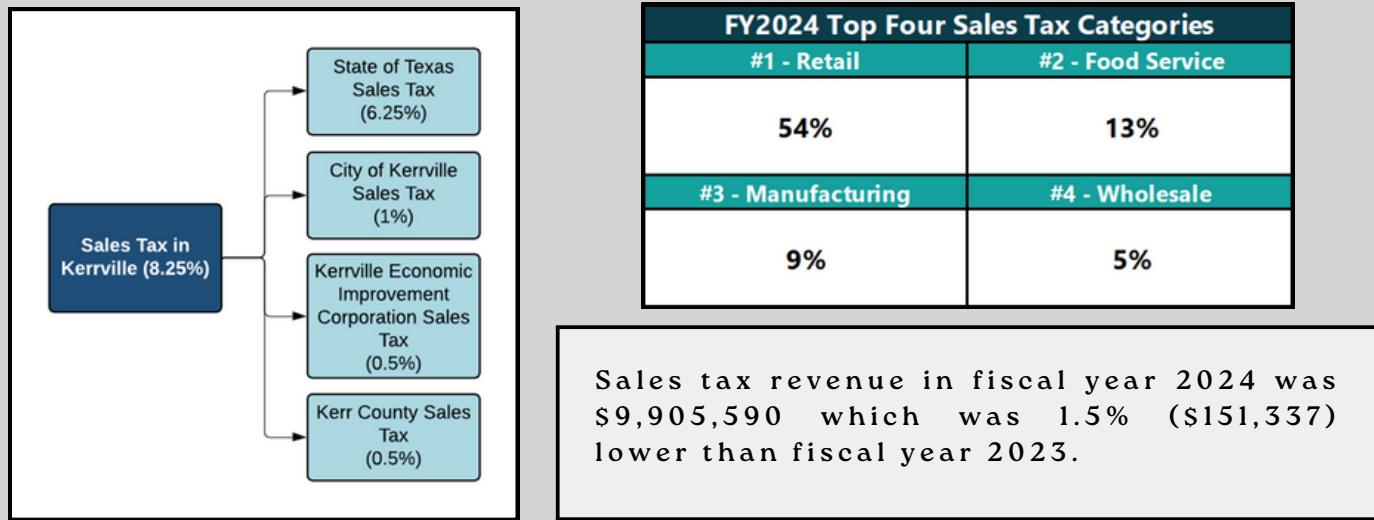
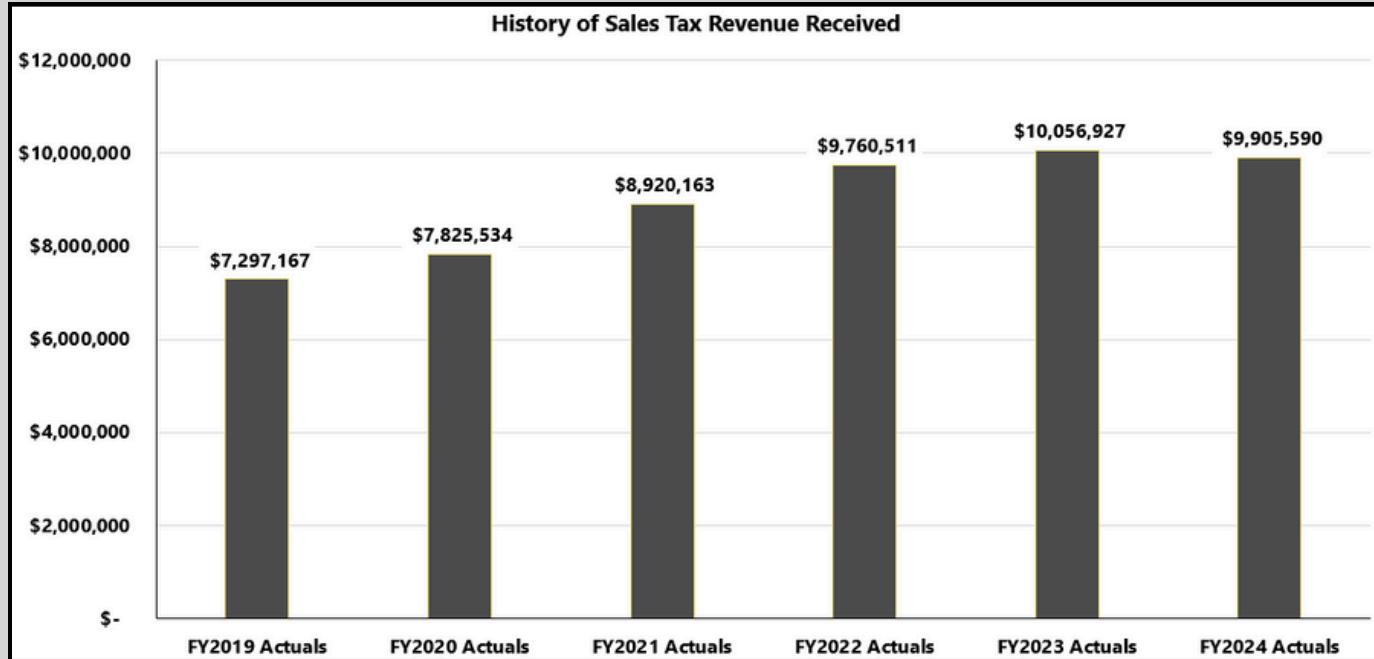


In fiscal year 2024 The City of Kerrville's overall property tax rate was \$0.5595 per \$100 of assessed value. Kerrville City residents paid a total property tax rate of \$1.86 per \$100 of assessed property value for all taxing entities. The image to the right demonstrates how property tax dollars were allocated among these various taxing entities.



Sales Tax

The City of Kerrville receives one and a half cents in sales tax each month from every dollar of taxable sales. One cent is allocated to the General Fund and half of a cent is allocated to the Economic Improvement Corporation (EIC). The EIC fund is one of the City's component unit funds. Component unit funds are not shown in the PAFR.



Page three of the ACFR discusses some of the inflationary pressures that are believed to have contributed to the leveling of sales tax compared to prior years. However, fiscal year 2024 Sales Tax Revenue ended 36% higher than fiscal year 2019, which is considered the last normal year before COVID-19. This is indicative of the continued strength of the City's economy.

Community Investment Plan

The Community Investment Plan (CIP) is a long-term, multi-year strategy for construction and infrastructure improvements, aligning with key priorities outlined in the Kerrville 2050 Comprehensive Plan. Reviewed annually by City staff and City Council, the CIP remains adaptable to evolving growth patterns, economic conditions, regulatory requirements, and Council priorities. As a planning tool, the CIP guides the identification of necessary capital improvements, cost estimation, and prioritization of projects but does not constitute a commitment to specific projects or funding. Each project is considered and approved individually by City Council.

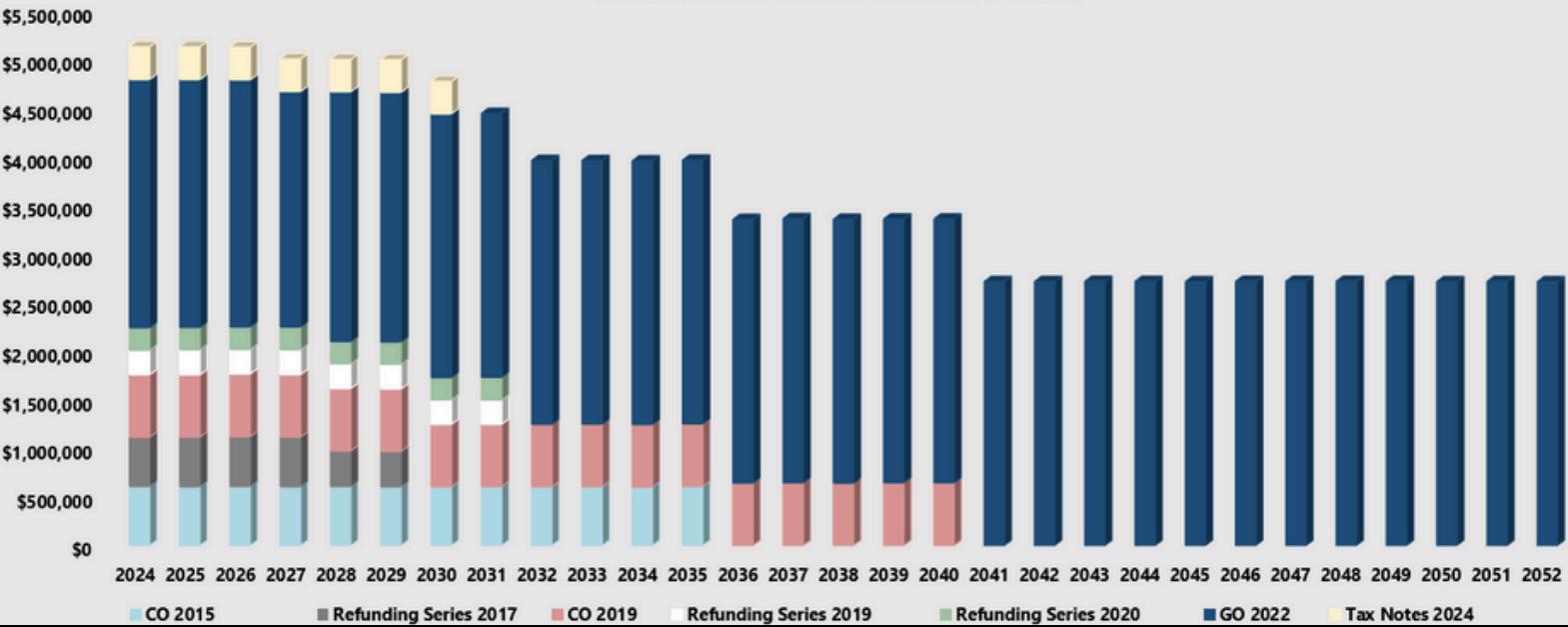

General Debt Service Fund

The City of Kerrville's General Debt Service Fund supports major public infrastructure projects, street improvements, and other capital assets. This debt service is primarily funded through Property Tax Revenue and 4B Sales Tax Revenue. The Kerrville Economic Improvement Corporation (EIC) allocates 4B Sales Tax Revenue to cover debt related to the River Trail, Kerrville Sports Complex, and other Quality of Life projects. The chart below shows the General Debt Service expense owed every year through 2052.

General Debt Service Fund



The City holds a "AA" bond rating from Standard & Poor's rating service for its general obligation debt. This rating indicates a high credit quality and investment grade status.

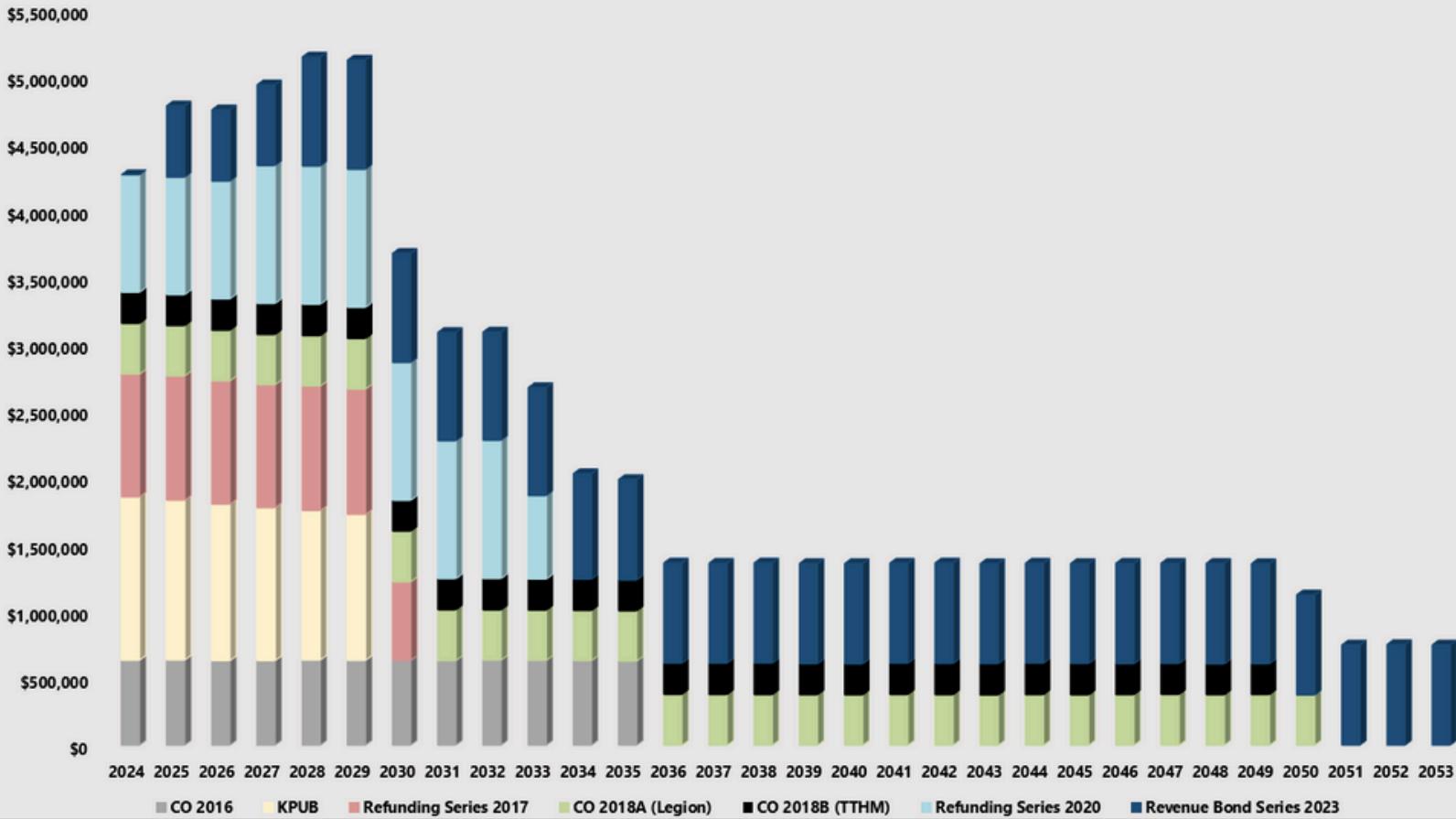

Water Debt Service Fund

The City of Kerrville utilizes the Water Debt Service Fund to finance significant public infrastructure projects such as wells, lift stations, pump stations, transmission lines, and water lines. The chart below shows the Water Debt Service expense owed every year through 2053.

The City holds a "A+" rating from Standard & Poor's for its Water Fund-issued debt. This rating indicates strong financial management and the ability to meet overall obligations, while acknowledging sensitivity to economic conditions.
