WHEREAS, Our Lady of the Hills is a Catholic High School located in Kerrville, Texas. OLH opened in 2002 with 19 students and has since grown its enrollment to 105 as of this year. It is a Christ-centered, co-educational college preparatory high school that offers a number of varsity sports, including boys' basketball. The school's boys' basketball program competes in the 3A Division of the Texas Association of Private and Parochial Schools as the OLH Hawks; and

WHEREAS, The Hawks' 2019 basketball team won their district with an unbeaten 8-0 record and finished the season 26-9 overall after defeating Midland Classical Academy, 50-47, in the TAPPS 3A Division state championship game Friday, March 1, 2019 at West, Texas gymnasium. OLH's victory produced the school's second-ever state championship in basketball, and third consecutive trip to the championship game; and

SUMMARY STATEMENT:

Public hearing, consideration, and action to recommend an ordinance to change the zoning from Planned Development District (PDD) to Airport District (AD) on approximately 23.84 acres, and consisting of Lots 1 and 2, Block One, of the OLH Subdivision (Volume

7, Page 158, recorded February 20, 2002), and Lot 3 and portion of Lot 2, Block Two, of the OLH Subdivision (Volume 8, Page 153, recorded December 21, 2009), within the City of Kerrville, Kerr County, Texas; and more commonly known as 235, 575, 581, and 601 Peterson Farm Road. (File No. 2018-099)

STAFF ANALYSIS

Consistency with the Kerrville 2050 Comprehensive Plan: The request is consistent with the Kerrville 2050 Comprehensive Plan. The subject property is located within Strategic Catalyst Area 11 which lies on the southeastern fringe of the City. "It is characterized by its most obvious and unique asset: the Kerrville Municipal Airport. Future growth will capitalize on the airport and its industrial space while keeping a careful eye on the effect of these activities on nearby neighborhoods."

Thoroughfare Plan: Highway 27 is designated as a Primary or Principal Arterial. Principal arterials typically serve as the highest traffic volume corridors, prioritizing longer-distance trips and providing connectivity between surrounding communities and major activity centers within Kerrville. A typical principal arterial is a four-lane divided roadway with a raised median, which can accommodate turning traffic at intersections and regulates access to the adjacent development. In rural and constrained areas or where there is a high volume of left-turning vehicles, the roadway may be undivided with a center turn lane at intersections. Peterson Farm Road and Spiltrock Road are not designated on the Thoroughfare Plan. Splitrock Road is a designated right-of-way by plat but is not fully constructed from Highway 27 to Peterson Farm Road.

ORDINANCE NO. 2019-06**

AN ORDINANCE AMENDING THE CITY'S "ZONING CODE" BY CHANGING A PORTION OF AN EXISTING PLANNED DEVELOPMENT ZONING DISTRICT (PDD); SUCH CHANGE TO REMOVE AN APPROXIMATE 23.84 ACRES FROM THE PDD, AND CONSISTING OF LOTS 1 AND 2, BLOCK ONE; LOT 3, BLOCK TWO; AND A 7.77 ACRE PORTION OUT OF LOT 2, BLOCK TWO; ALL LOTS BEING OUT OF THE OLH SUBDIVISION, SAID SUBDIVISION WITHIN THE CITY OF KERRVILLE, KERR COUNTY, TEXAS; SUCH PROPERTIES MORE COMMONLY KNOWN AS 235, 575, 581, AND 601 PETERSON FARM ROAD; BY REMOVING THESE PROPERTIES FROM A PDD AND PLACING EACH WITHIN THE AIRPORT ZONING DISTRICT (AD); CONTAINING A CUMULATIVE CLAUSE; CONTAINING A SAVINGS AND SEVERABILITY CLAUSE; PROVIDING FOR A MAXIMUM PENALTY OR FINE OF TWO THOUSAND DOLLARS (\$2000.00); ORDERING PUBLICATION; AND PROVIDING OTHER MATTERS RELATING TO THE SUBJECT

WHEREAS, pursuant to Texas Local Government Code Sections 211.006 and 211.007, notice has been given to all parties in interest and citizens by publication in the official newspaper for the City of Kerrville, Texas ("City"), and otherwise, of a hearing which was held before the City Council on March 12, 2019, which considered a report of the City's Planning and Zoning Commission regarding its recommendations on this Ordinance, the adoption of which will result in the change of a zoning district for the property consisting of approximately 23.84 acres and generally located at 235, 575, 581, and 601 Peterson Farm Road; such change to result in the removal of the property from a Planned Development District, as established by Ordinance No. 2001-20 and amended by Ordinance No. 2008-32, to placement within the Airport Zoning District (AD); and

WHEREAS, such public hearing was held in the Council Chambers beginning at approximately 6:00 p.m. on March 12, 2019, as advertised; and

WHEREAS, after a full hearing, at which all parties in interest and citizens were given an opportunity to be heard; and after receiving and considering the recommendations of the Planning and Zoning Commission and City staff; and after considering among other things, the character of the various areas of the City and the suitability of particular uses in each area; and with a view to conserving the value of buildings and encouraging the most appropriate use of land throughout the City, the Council finds it to be in the best interest of the health, safety, morals, and general

welfare of the City of Kerrville, Texas, to amend the City's Zoning Code to change the zoning district for the property described below by placing it within the Airport Zoning District (AD);

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KERRVILLE, KERR COUNTY, TEXAS:

SECTION ONE. The zoning district for the following property generally located at 235, 575, 581, and 601 Peterson Farm Road is changed from a Planned Development Zoning District (PDD) to the Airport Zoning District (AD):

Being approximately 23.84 acres situated within the city of Kerrville, Kerr County, Texas, and consisting of Lots 1 and 2, Block One; Lot 3, Block Two; and a 7.77 acre portion out of Lot 2, Block Two, of the OLH Subdivision, according to the plat thereof recorded in Volume 7, Page 158 and Volume 8, Page 153 of the Plat Records of Kerr County, Texas; said 23.84 acres being more particularly depicted as Exhibit A, attached hereto and made a part hereof for all purposes.

SECTION TWO. The City Manager or designee is authorized and directed to amend the City's official zoning map to reflect the change in districts adopted herein and to take other actions contemplated by and in accordance with Section 11-I-4(c) of the City's Zoning Code.

SECTION THREE. The provisions of this Ordinance are cumulative of all other ordinances or parts of ordinances governing or regulating the same subject matter as that covered herein; provided, however, that all prior ordinances or parts of ordinances inconsistent with or in conflict with any of the provisions of this Ordinance are expressly repealed to the extent of any such inconsistency or conflict.

SECTION FOUR. If any section, subsection, sentence, clause, or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such holding shall not affect the validity of the remaining portions of this Ordinance. City Council declares that it would have passed this Ordinance and each section, subsection, sentence, clause, or phrase hereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared unconstitutional or invalid.

SECTION FIVE. The penalty for violation of this Ordinance shall be in accordance with the general penalty provisions contained in Section 1-7, Chapter 1 of the Code of Ordinances of the City of Kerrville, Texas, which provides for a fine not exceeding TWO THOUSAND DOLLARS (\$2,000.00).

SECTION SIX. Pursuant to Texas Local Government Code §52.013(a) and Section 3.07 of the City's Charter, the City Secretary is hereby authorized and directed to publish the descriptive caption of this Ordinance in the manner and for the length of time prescribed by the law as an alternative method of publication.



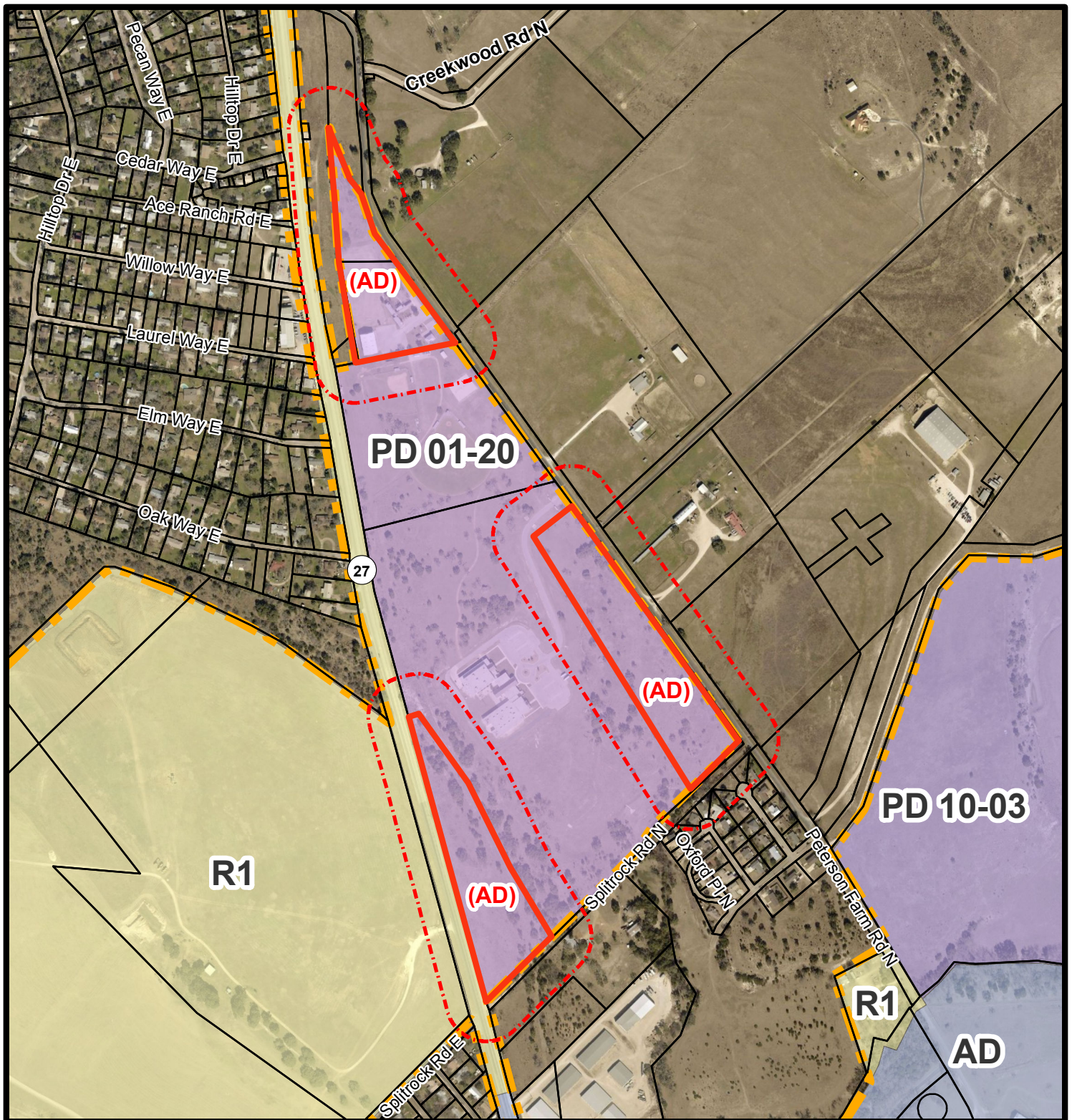

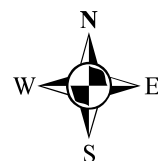
Location Map

SUMMARY STATEMENT:

GENERAL FUND:

Year to date through February 28, 2019, the General Fund has recorded revenue of \$16.0 million compared to expense of \$10.8 million. It is normal for revenue to be higher than expenditures at this time of year because most property taxes are due by January 31st. Items to note for February include:

1. Property tax collections are ahead of FY2018, but slightly lower than budget. The overall property tax collection rate has been very stable for many years, so this appears to be a timing issue only.
2. February 2019 sales tax increased 6.03% compared to February 2018. Year to date, sales tax is up a healthy 4.70%, led by increases in manufacturing, food service and construction. February sales tax 2019 payment, representing tax collected on December

sales, was the largest single month sales tax payment ever received by the City.

WATER FUND:

Year to date through February 28, 2019, the Water Fund received revenues of \$4.4 million compared to expenditures of \$4.9 million. Notable activity includes:

1. Water and reuse sales are lower than budget and FY2018 due to record rainfall amounts in October 2018. Water sales are very volatile and highly weather dependent, so it is possible that dry conditions later in the year could offset extremely wet conditions this fall. However, we are proactively monitoring expenditures in order to offset some of the lost revenue.
2. Water Fund Other Revenue is lower in FY2019 because FY2018 includes a one-time \$415 thousand transfer related to the December 2017 debt refinancing.
3. Water expenditures are lower than FY2018 because \$272 thousand was transferred to the Capital Projects Fund for the Legion Lift Station project in October 2017. This transfer did not recur in FY2019. In addition, expenditures are better than budget due to lower than anticipated chemical and maintenance costs.

DEVELOPMENT SERVICES FUND:

Year to date through February 28, 2019, the Development Services Fund received revenues of \$471 thousand compared to expenditures of \$704 thousand. Revenue includes transfers in from the General Fund and Water Fund of \$295 thousand and permit and fee revenue of \$176 thousand. FY2019 expenditures include a transfer of \$379 thousand to a projects fund for the code rewrite and Development Services software projects. The Development Services Fund was broken out of the General Fund in FY2019. For presentation and comparison purposes, FY2018 financial information is shown in the Development Services Fund rather than the General Fund.

GOLF FUND:

Year to date through February 28, 2019, the Golf Fund received revenues of \$279 thousand compared to expenditures of \$367 thousand. FY2019 revenue is lower than budget and FY2018 primarily due to record rainfall in October and bad weather days in December.

HOTEL OCCUPANCY FUND:

Year to date through February 28, 2019, the Hotel Occupancy Fund received revenues of \$494 thousand compared to expenditures of \$589 thousand. Revenue includes a \$24K audit settlement payment from Yogi Bear.

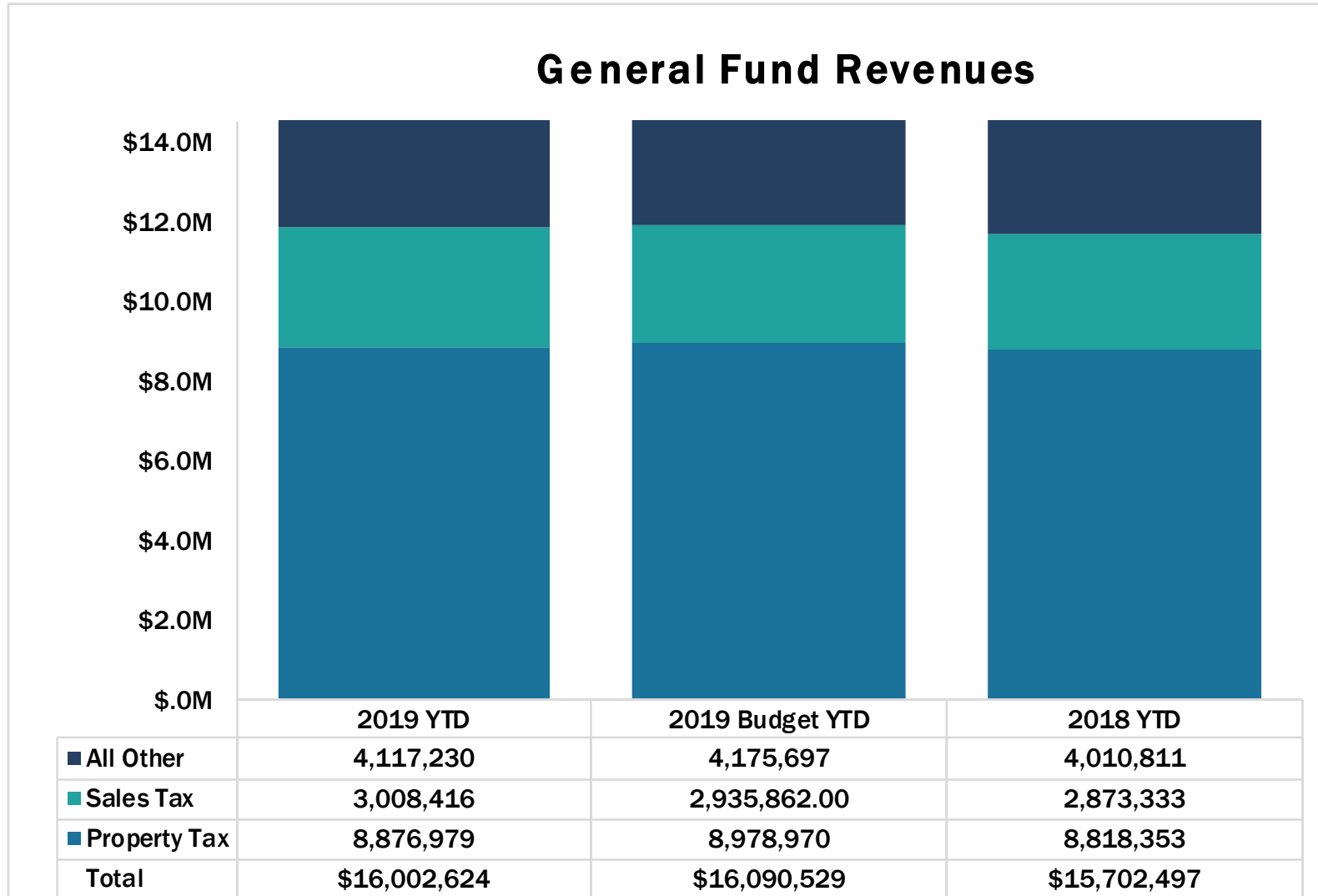

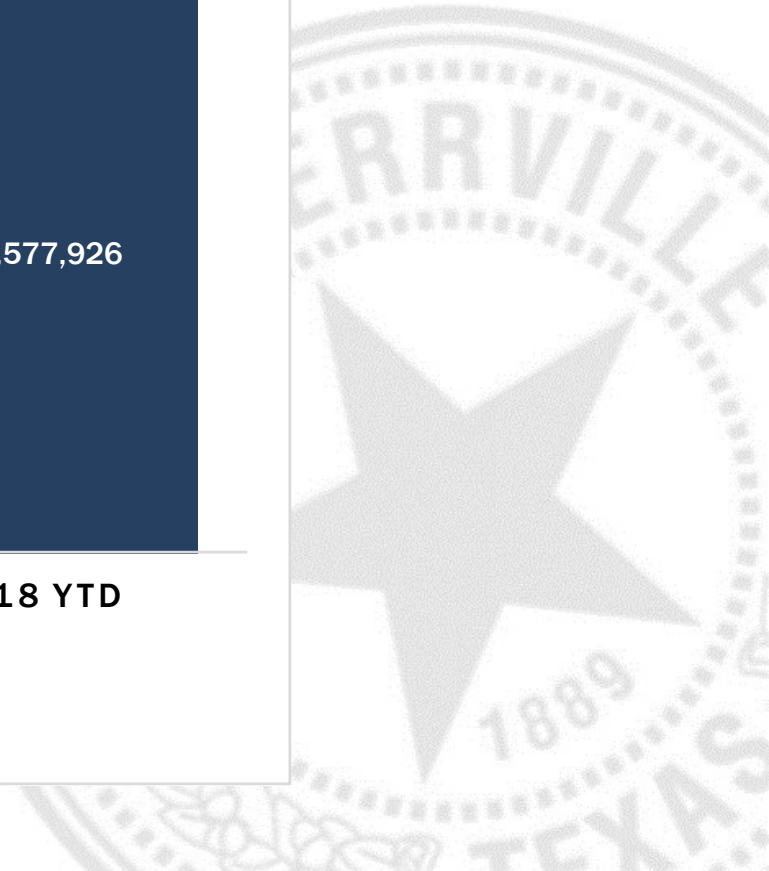
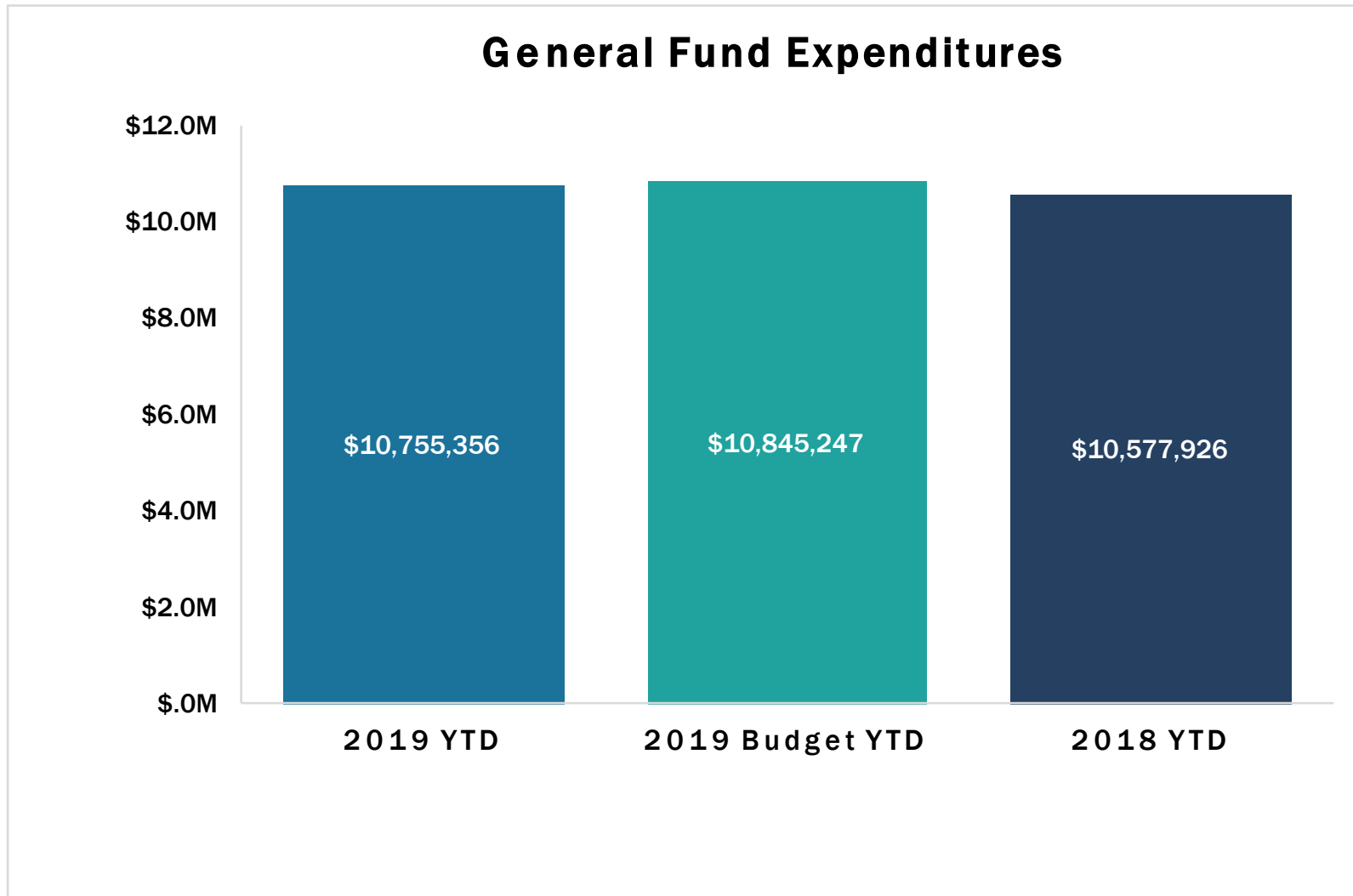

General Fund Revenues





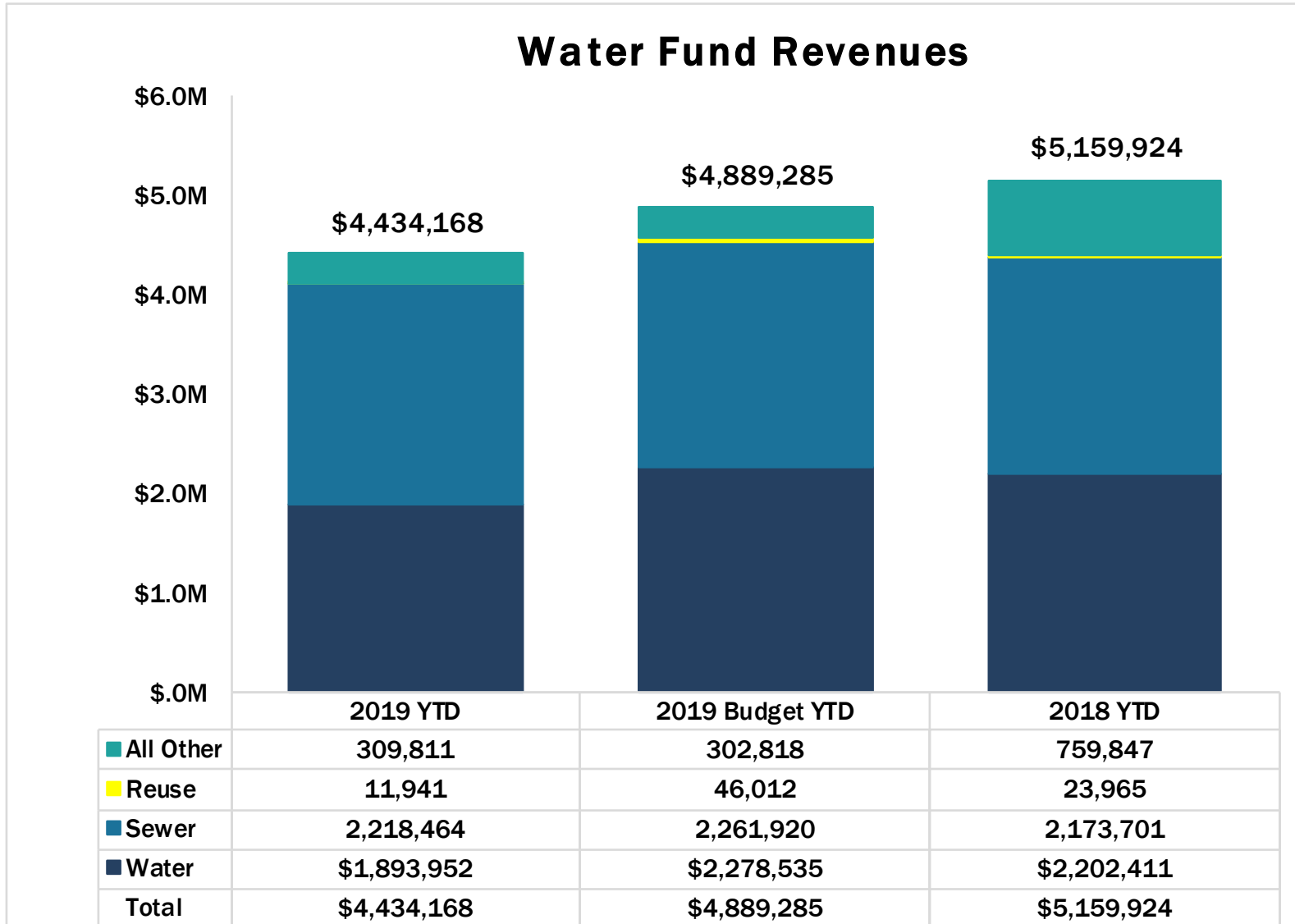
General Fund Expenditures



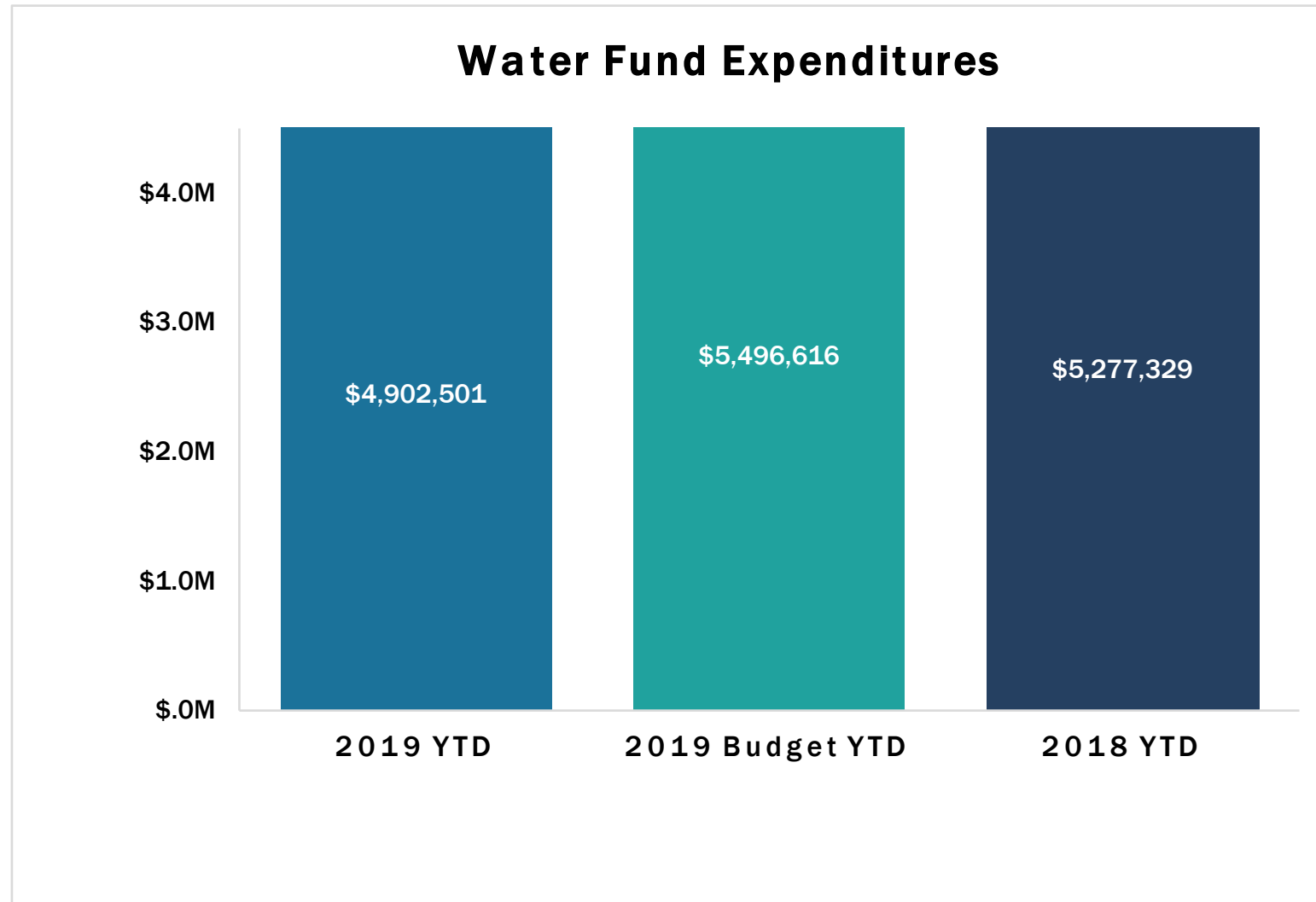
