Mr. Irvin moved to approve the variance; motion was seconded by Mr. Ligon and passed 5-0.

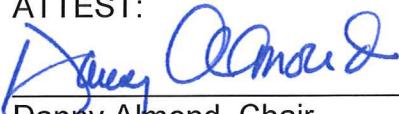
4. STAFF REPORTS

5. ADJOURNMENT

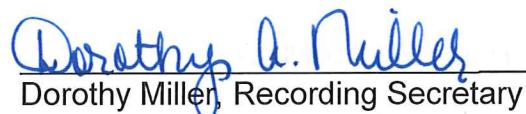
