**4. VISION 2020 COMMUNITY RECOVERY EVENTS**

4A. Brian Brannon gave an update on the list of events that Starlite is implementing. If you build it, they will come is the concept. As a review of events, there was a supplies rally and food rally by Sober Homes. Also, they participated in the Holiday Lighted Event and a Haunted House. At Christmas, they teamed with Divinity Sober Living and held a toy drive. Over 100 people attended the Sober New Year's Eve Party at Starlite. The Starlite Ambassador Program is Warrior's Heart, Serenity House, Right Step and Promises, Northstar Sober Living, New Traditions, Crossroads Sober Living, Fog House, and several others have teamed up to come together to host events. This February there will be a Variety Show. Many of the Sober Living homes will be providing either monetary or assistance with the program. There will be artists, singers, and a drag show. That is on February 8, 2020. This Coalition also put on the Recovery Rally last May and the committee met to plan the next rally. It is March 21, 2020 this year at Louise Hays Park at the Pavilion. KRCC is listed as a participant and this Board needs to be more involved in the event. Brian asked that we brainstorm and discuss the emphasis for participation in community events. It is also our hope to incorporate our youth in our events, as well as those that struggle with mental health issues. We also want to have resources available at the Recovery Rally to coordinate services with individuals in need. As a Coalition/Board, what do we really have to contribute? We need to access our time and resources to make them available to those in recovery. There will be another meeting for the Rally in a couple of weeks and Brian Brannon will be sending out that information. All emails for this Coalition will be funneled through Mary Segovia.

4B. Dr. Kendall Young- Update on pop-up events happened and were fun. The Coalition unanimously agreed to have the August Night of Remembrance event again. We hope to schedule events, publicize them, and involve individuals in recovery and our community into meaningful programming. Members asked if we could do a Meet and Greet of our Coalition for our community and recovery community. There will also be a Resume and GED Program that will be held in March 2020. It was a request from our recovery community so we will be offering that program. We want to host events or programs that truly meet the needs and interests of our recovery community.

As well, there is now a consistent pain management plan based on protocols with all doctors at Sid Peterson Hospital.and there are supports that will fill in on the side to provide additional support. The Standard Operating Procedures are now in place and implemented. As soon as it is implemented then it will be shared with local doctors as information to allow them to mirror these procedures.
