September 27, 2021

1. APPROVAL OF MINUTES:

1A. Approval of minutes of the June 28, 2021 meeting. *Mr. Hurt move approval and Mr. Stolpman seconded, the minutes as written. Approved unanimously.*

2A. Introduction of Partners and Guests. *Chief Maloney introduced Ms. . Intern for the Fire Department, who is working on a student report of areas of Schreiner University/COK collaboration. He invited members to reach out to her.*

**3. STATUS UPDATES FROM MEMBERS AND GROUP DISCUSSION RE:
REDUCTION OF BARRIERS AND ENHANCEMENT OF POSITIVE
RELATIONSHIPS**

3A. Sites for provision of medically assisted treatment (MAT) *–No presentation*

was available at the time of this meeting.

3B. Reduction of legal barriers to employment (pathways to TDL/ID reinstatement and warrant management);

a) Drug Court update; *Steve Harpold, prosecutor for the 198th Circuit Court, gave an overview of the drug court program, which began about two years ago. The program was made available to law offenders that had a history of problems with alcohol or drugs as an option to a punishment program. Volunteers that sit on the court meet twice a month to consider cases. The applicants must qualify as shown in a form that they'd previously filled out. Probationers are sent to detox, then they report back to the drug court, where they continue with community service and outpatient treatment, such as Creekview IOP. As of this time, the program has had three "graduates" and there are currently eight active participants. Not completing the program is considered a violation of probation. Coalition members had questions comments, including 1) that some have seen it work well 2) how does the treatment part work in practice 3) housing and jobs need to be a central part of such a program 4) is judicial clemency and option. Mr. Harpold responded that there are groups that work with the court, such as Magdalene's House, Medina Children's Home, and the Christian Job Corps. There is a chart of "minor" penalties, such as reduction of privileges, curfews, etc. that can be imposed if certain performance standards are not met. Judicial clemency has happened before, but likely not enough.*

b) Overview of ID Recovery Clinic; *Ms. Kennison Evans, Hill Country Public Defender, gave an overview of the program. Some people that are early in recovery might have lost or had stolen their ID's, which could make it difficult if not impossible to take positive action to change their way of living. There is a lot of documentation required, which quickly become difficult if not impossible, especially if there is a change of name involved. Law students help the applicant through the cumbersome process to gather the background paperwork. Haven for Hope, the nonprofit that had some space devoted to this work, but currently more space is needed to allow for weekly or biweekly work. Mr. Dupris mentioned that there is currently no central point to send people. Ms. Kennison responded that there is one at Club 12 in San Antonio. Schreiner University might be interested in collaborating.*

3C. Accessibility of existing public resources; Overview of Health and Wholeness Questionnaire; Kerr County Interagency Network – *No presentation was available at the time of this meeting*




