*Pursuant to Section 46.03, Penal Code (places weapons prohibited), a person may not carry a firearm or other weapon on this property.*

City Council will discuss the following in Executive Session:

3.A. Interlocal Agreement between Kerr County, Texas, and the City of Kerrville, Texas for the provision of Animal Control Services within the City and Services of the Butt-Holdsworth Memorial Library for Residents of Kerr County. (551.071)
