## Kerrville Municipal Court



### Why Teen Court?

- Legislature mandated diversion policy starting on January 1, 2025
- Applies to juveniles between 10-16
- Teen Court is an approved diversion option
- Ensure that juveniles have an opportunity to enter adulthood without a criminal record that could impede their educational, employment, and military opportunities.

# What is Teen Court?

## Teen Court is Court

1. Guilt and innocence will not be determined by the jury; punishment is the only thing to be addressed in teen court.
2. The court session will occur on select Tuesday evenings each month during the school year.
3. The attorneys handling the prosecution and defense will be teenagers.
4. The six-person jury will be comprised of a mix of teen volunteers with the Kerrville Teen court and prior defendants who have been sentenced to participate in a certain number of jury panels as part of their punishment.
5. Judge Pearson will be the Teen Court Judge.
6. The bailiff will be the City Marshal.

## Timeline

- Court personnel presented teen court to Tivy students on April 29, 2024.
- Received a total of 35 applications.
- Interviewed 27 applicants the last 2 weeks in May.
- Held first training session for teen attorneys and jurors on July 26, 2024.
  - We had 17 students appear
  - An additional three (3) agreed to attend a training session in September.
- Began offering Teen Court as an option to juvenile defendants on August 5, 2024.
  - Two juvenile defendants have already opted for teen court
