Citizens wishing to speak during a meeting shall submit a completed "speaker request form" to the City Secretary before the item is introduced, but are encouraged to submit the form before the meeting begins. Each speaker is limited to four minutes.

Pursuant to Section 30.06, Penal Code (trespass by license holder with a concealed handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a concealed handgun.

Pursuant to Section 30.07, Penal Code (trespass by license holder with an openly carried handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a handgun that is carried openly.

Pursuant to Section 46.03, Penal Code (places weapons prohibited), a person may not carry a firearm or other weapon on this property.

 - 2.A Deliberation of competitive matters regarding wholesale market activities of the Kerrville Public utility Board (KPUB), to include power supply projects. (551.086) (*D Rice, City Manager / requested by M Wittler, CEO KPUB*)
 - 2.B City Manager Annual Evaluation (551.074) (*K Meismer, Assistant City Manager*)
