SUMMARY STATEMENT

Should City Council decide to close on the purchase of the property located at 529 Water Street authorization to execute purchase documents is required. The option period for this property expires on October 12, 2015, and City Council action is sought in order to meet the contract timeline. Specifically, authorization is needed for the following items:

- <u>Amendment to One to Four Family Residential Contract (Resale)</u> eliminates a requirement of the City of Kerrville.
- <u>Donation Agreement</u> establish a three-party agreement to establish deed restrictions to limit the use of the property to support library operations, and
- <u>General Warranty Deed</u> accept the deed that establishes the deed restrictions established in the Donation Agreement.

This property is being purchased through a gift to the City of Kerrville.
