There was much discussion regarding the various ideas for decorations, booths, wine glasses, plates, and lighting. It was suggested that perhaps KPUB would be willing to install more permanent lighting and outlets in the area where Mardi Gras on Main was planned.

Mr. Martin spoke about banners, and using some of the Mardi Gras art submissions on them.

Ms. Snyder gave the board a report of the Parade, and showed a presentation of various floats and the winners of the prizes.

Downtown Christmas Lighting:
