***Main Street Meeting Procedures during the Disaster Declaration***

*The Kerrville Main Street Advisory Board will conduct its January 27, 2021 meeting as a meeting that is open to public attendance. COVID-19 (Coronavirus) provides unique concerns in that gathering members of the public and City staff within a physical setting may constitute a public health risk. In an effort to avoid and mitigate health risks, standard safety protocols must be observed by board members, City staff, and citizens/visitors attending this meeting. Anyone attending this meeting must wear a mask into City Hall, sanitize their hands, and have their temperature taken prior to entering Council Chambers. Anyone with a temperature greater than 100.2 will not be allowed entry. All attendees must wear a mask at all times. The City will observe six-foot distance seating and will designate allowable seating. Once capacity is reached, overflow seating will be provided in the Lobby and Upstairs Conference Room. The public podium will be sanitized between each speaker. Note that no online (virtual) meeting is offered for this meeting*
